PROJECT AGREEMENT

This agreement is made between **ONE DOLLAR PROJECT INC** and **PARK ROAD YOUTH GROUP**.

Both parties agree that their conduct in this agreement will be according to the principles of Islam derived from the Quran and the Sunnah of the Holy Prophet Muhammad (S.A.W)

The terms of this agreement are stipulated below:

1. THE PROJECT

The project is to provide food ration to fasting families on or before the month of Ramadhan in the year 2014 which is expected to start 29th or 30th June 2014. Food ration per family is to contain the following items;

- i. 10 Kgs of Wheat flour
- ii. 10 Lts of Cooking oil
- iii. 1 Kg of Tea Leaves
- iv. 12.5 Kgs of Rice
- v. 0.5 Kgs of Salt
- vi. 7 Kgs of Sugar
- vii. 8 Kgs Spaghetti
- viii. 10 Kgs of Maize flour

2. FUND TRANSFER

All funds collected by One Dollar Project Inc are to be transferred through telegraphic transfer to Park Road Youth Group. All funds transferred are to be used for the sole purpose of the project.

3. LOCATION OF PROJECT

The project is to distribute food ration to families in Kenya with majority living in Nairobi and its environs.

4. OWNERSHIP OF THE PROJECT

The project is a joint effort between the two parties and both parties, One Dollar Project Inc and Park Road Youth Group, agree to have a joint ownership over the project.


5. CONTACT PERSONS FOR THE PROJECT

6. REPORTING ON THE PROJECT

Park Road Youth Group will undertake the following aspects in relation to reporting on the project;

- i. Video record each segment of the project which include and is not limited to;
 - a. Purchase of food ration,
 - b. Packing food ration into family portions,
 - c. Distribution of food ration to families,
 - d. For a selected number of families, record the delivery of food ration to their doorstep.
- ii. Have a narrator in the video who will introduce the project to the viewers
- iii. At the end of the video inform the viewer the total number of families that have benefited from the project
- iv. The beginning of the video should indicate ownership of the project as per point No. 4 above, with both logos shown.
- v. The video is to be uploaded on YouTube before the 15th day of Ramadhan which is expected to be 13th or the 14th June 2014.
- vi. Submit a summarized financial report showing the project income and expenses.
